Data processing policy for complaints

Your personal data provided in course of sending your complaint to Hungerit Zrt. will not be accessible to third persons.

HUNGERIT processes your personal data in course of sending your complaints for 5 years from the date of receiving the complaints.

You have the right to request to access to your personal data, erasure of your personal data or restriction on processing your personal data. You have the right to request rectification of your personal data except for rectification of the voice recording. The legal basis of the processing of personal data is your consent that is given by sending your personal data for the purpose of settling your complaint.

Your personal data provided in course of settling your complaint will not be accessible to third persons.

A HUNGERIT processes your personal data in course of settling your complaints for 5 years from the date of receiving the complaints.

You have the right to request to access to your personal data, erasure of your personal data or restriction on processing your personal data. You have the right to request rectification of your personal data except for rectification of the voice recording. The legal basis of the

processing of personal data is your consent that is given by telling your message to the voicemail recorder.

Your personal data provided in the message will not be accessible to further persons.

A HUNGERIT processes your personal data you provided in the message for 1 year, in case the message contains complaints, for five years from the recording.

You have the right to request to access to your personal data, erasure of your personal data or restriction on processing your personal data. You have the right to request rectification of your personal data except for rectification of the voice recording. Data processing for ordering

HUNGERIT Baromfifeldolgozó és Élelmiszeripari Zártkörűen Működő Részvénytársaság (seat: 6600 Szentés, Attila u. 3.; court registration number: 06-10-000211; „HUNGERIT”) processes your personal data you provided in course of your order made through the voicemail recording system to HUNGERIT for the purpose of complete the orders and issue the relevant invoices.

In case the purchase is private individual the legal basis of data processing with respect to the completion of the order is performance of contract and with respect to issuing the invoice the legal obligation to issue and keep the invoices.

In case the purchaser is not private individual the legal basis of the data processing with respect to issuing the invoice is legal obligation related to issuing and keeping the invoices. The legal basis of processing the personal date with respect to the orders and the contact details is the legitimate interest of HUNGERIT. The legitimate interest of HUNGERIT is to be able to contact with the contact person of its partner.

Your personal data provided with respect to the order will not be accessible to further persons.

A HUNGERIT processes your personal data provided with respect to the order until the end of the limitation period. HUNGERIT processes personal data provided for the purpose of issuing invoice for one month following 8 years as from the issuance of the invoice for the purpose of complying with the requirements of the keeping the invoices by law.
